Infrastructure assistance - Infrastructure projects have multiple benefits and are undertaken to support our efforts in education, health, and economic development. A simple project can make a significant difference in the lives of all villagers. Shanta supported two villages to install solar lighting systems in 175 homes, helped construct a new clean water system in a third village, and supported the construction of a new primary school in a fourth village.

Education and Health Services - A successful educational system inspires a lifetime love of learning and is critical to cementing long-term change in village development. Shanta provided opportunities for all village children to gain a comprehensive education by providing 69 middle, high school and university scholarships and also held an English language summer school for 38 children. Shanta also provided monthly supervision of five village nurses and led training for 36 women who facilitated educational workshops for 693 reproductive-age women in safe motherhood practices. The annual dental clinic examined and treated 553 children and adults.

Economic and Leadership Development - Economic development projects create financial growth opportunities for all families, especially women, to increase quality of life and provide funding for village development activities. Shanta initiated 14 pig farms, 400 coffee farms and other small business development. In addition, Shanta initiated two community lending programs and one new business loan program. Shanta also provided leadership development for 90 village managers through continuous training and community workshops.
